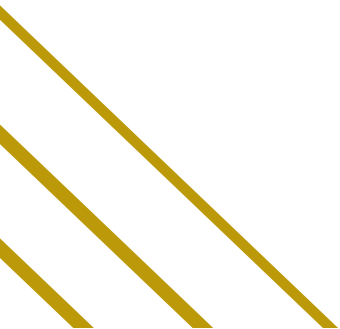
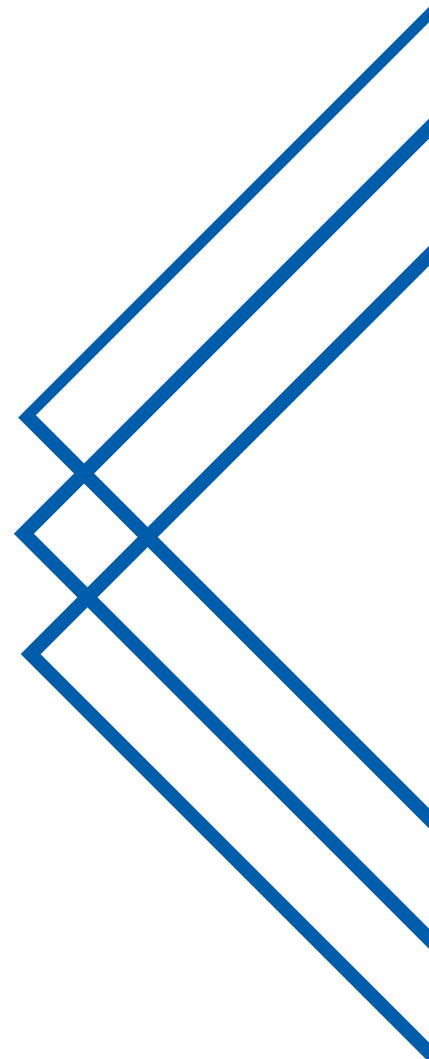
# Overview of worksites

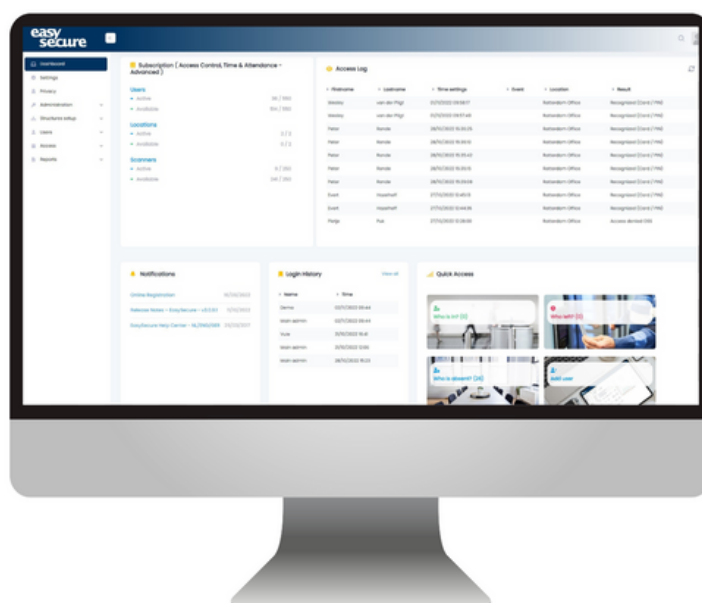
